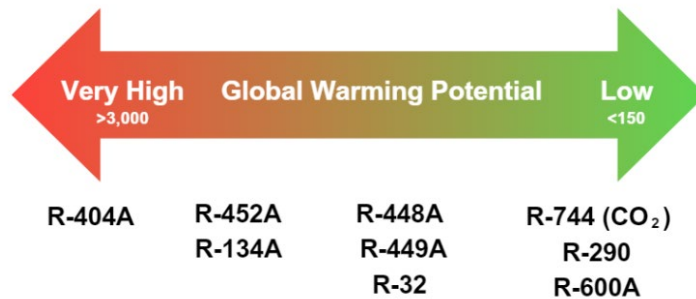


# Healthy Refrigeration Grant Program

## Appendix A - Partial List of Previously Purchased Equipment

This program promotes the use of climate-friendly and energy efficient refrigeration equipment and requires the use of refrigerants with a low global warming potential (GWP).



**When there is a choice of refrigerants used, applicants must select the lowest GWP option.** Applicants will be asked to identify the refrigerant used in their application and may need to specify the desired refrigerant when purchasing equipment. Applicants may select the units that work best for their needs within the range of allowable and available, energy-efficient and climate-friendly choices.
