## **Purpose and Priorities**

The 2023 Urban Agriculture Grant Program will award competitive grants to support projects that enhance the viability of urban agriculture in urban areas across California.

#### Funding **Priorities**:

- Priority will be given to urban agriculture projects led by or serving priority populations as defined by the California Air Resources Board's California Climate Investments Priority Populations map
- Projects whose benefits expand beyond the individual benefit of the applicant
- Projects that clearly display one or more of the benefits of urban agriculture



## **Urban Agriculture Definition**

Urban Agriculture refers to the cultivation, processing, and distribution of agricultural products in urban settings, including things like inground small plot cultivation, raised beds, vertical production, warehouse farms, mushroom growing, urban forestry and tree care, community gardens, rooftop farms, hydroponic, aeroponic, and aquaponic facilities, and other innovations. Urban farmers and gardeners work among diverse populations to expand access to nutritious foods, foster community engagement, offer workforce development opportunities, educate communities about food and farming, and expand green spaces.

CDFA defines "urban" as a geographic area no more than 25 miles adjacent to or outside of one Urbanized Area containing a population of 50,000 or more people.

## **Benefits of Urban Agriculture Include**

- Builds Social Capitol and Gathers Communities
- Provides Education and Skills Development
- Supplements Access to Fresh Food
- Cultivates Agricultural Literacy
- Performs Ecosystem Services
- Supports Economic Development
- Increases Food Sovereignty
- Pilots an Innovation in Production



## What is Food Sovereignty?

The right of peoples to healthy and culturally appropriate food produced through ecologically sound and sustainable methods, and their right to define their own food and agriculture systems.

**Key Note:** Produce grown does NOT need to be for sale to qualify as Urban Agriculture

#### **Example Projects:**

- Building a Community Garden
- Supporting Home Production by:
  - Hosting Community Workshops
  - Seed/Starts Distribution to your community
  - Providing Technical Assistance to Home Gardeners



## **Two Funding Tracks**

Track 1: Systems Builder Community-Based Block Grant

Track 2: Urban Agriculture Practitioner Grant



No, you may not apply to both funding tracks



If you receive a Track 2 award, you **cannot** also receive Track 1 subaward funding

YES you may apply if you have an existing grant with CDFA

If you apply for Track 2 but **DO NOT** receive an award, you can still apply for a subaward from the Track 1 funded organization in your region.



### Track 1: Systems Builder Community- Based Block Grant (purpose)

**The purpose of the Systems Builder Community-Based Block Grant** is to increase staff capacity and provide pass through funding for Community-Based Organizations (CBO's) with grassroots involvement in urban and regional food systems planning. Eligible CBO's may apply for awards from \$200,000 - \$800,000 in CDFA funding to engage and administer subawards to urban agriculture stakeholders in their region. Track 1 funded Organizations may utilize between \$5,000-\$60,000 of the award towards eligible urban agriculture work being done internally. Subawards to external stakeholders will range from \$5,000 to \$60,000.



### Track 1: Systems Builder Community-Based Block Grant Overview

Track 1 will fund Community-Based Organizations (CBO's) with grassroots involvement in urban and regional food systems planning to increase their capacity in order to create and administer subawards to urban agriculture stakeholders in their region.

- Design the subaward application. KEEP IT SIMPLE. This could be an interview, a site visit, a written application, or any other method that the CBO sees fit for equitably determining which projects meet the criteria of urban agriculture as defined by CDFA.
- Develop an effective communication strategy to promote the subaward opportunities including strategies such as language translation as necessary, radio, press, or web-based media, hosting town halls, community gatherings, newsletters, listservs, and more.
- if desired, employ Systems Builder Block Grant staff and/or pay existing staff.
- Distribute subawards to no less than two urban agriculture stakeholders in your region there is no maximum number.



### Track 1: Systems Builder Community-Based Block Grant Regions

A minimum of one CBO will be funded per region. A minimum of one CBO will be funded with statewide reach.

## Track 1: Systems Builder Community-Based Block Grant Eligibility



... with grassroots involvement in urban and regional food systems planning. Priority given to organizations that have led or participated in creating a Food System Assessment, Greening Plan, Climate Action Plan, Urban Agriculture Assessment, Food Policy Development Plan/Strategie and or other related community fed research assessing their reginal assets and needs.



## **Track 1:** Details

Grant Term: May 2024 through September 2026 (28 months)

Funding Range: \$200,000 minimum - \$800,000 maximum

**Allowable Costs:** Staffing needed to create, advertise and administer subawards to underserved urban agriculture stakeholders in your region. No less than 2 subawards. \$5-\$60k for applicant urban agriculture project.

#### Subawards Range from \$5,000-\$60,000 for:

- Infrastructure
   Workforce Development
- Community Engagement

- Equipment/Supplies
   Technical Assistance
- Operations

#### **Reporting:**

- Annual reports cover progress made during the first twelve months of a project and successive annual periods thereafter.
- Final report covering progress made during the entirety of the project include data, results, and discussion from all years of the project to form a comprehensive and stand-alone document.
- Quarterly check-ins (what's working, how can we help)
- Evaluation including survey collection, data collection as agreed upon and interviews with subawardees.

## Track 2: Urban Agriculture Practitioner Grant Overview

Track 2 will fund urban agriculture projects that are led by or serve priority populations in urban areas throughout California.

- The <u>California Climate Investments Priority Populations Map</u> will be used to identify priority populations that are disadvantaged and/or low-income.
- Projects that clearly execute one or more of the **benefits** of urban agriculture.
  - Builds Social Capitol and Gathers Communities
  - Provides Education and Skills Development
  - Supplements Access to Fresh Food
  - Cultivates Agricultural Literacy
  - Performs Ecosystem Services
  - Supports Economic Development
  - Increases Food Sovereignty
  - Pilots an Innovation in Production

## CA Native American Tribes

All applicants must meet the definition of a Qualified Small Business: Is one of the following: (exception for Tribal Applicants)

- A sole proprietor, independent contractor, 1099 employee, C-corporation, S-corporation, cooperative, limited liability company, partnership, or limited partnership, with an annual gross revenue of less than five million dollars (\$5,000,000), but greater than one thousand dollars (\$1,000), in the 2022 taxable yea.
- A registered nonprofit that had an annual gross revenue of less than five million dollars (\$5,000,000), but greater than one thousand dollars (\$1,000), , in the 2022 taxable year.
- ✤ An organization that is fiscally sponsored by a nonprofit corporation.

Allowable Costs: We aim to provide flexible funding to meet the needs of your urban agriculture project in accomplishing one or more Benefits of Urban Agriculture

#### **Reporting**:

- ✤ 5-10 photos of the site, project, or infrastructure you plan to improve with grant funding at the start and end of the project.
- Annual reports cover progress made during the first twelve months of a project and successive annual periods thereafter.
- Final report covering progress made during the entirety of the project include data, results, and discussion from all years of the project to form a comprehensive and stand-alone document.
- Evaluation including survey collection, data collection as agreed upon during the final agreement.

## Timeline

June 2023: public comment period

- August 21 October 23, 2023: applications open (online portal)
- November January 2024: review and scoring applications
- February 2024: notification to awardees
- February May 2024: contracts and grant agreements created
- \* May 2024: funding released, and projects start
- September 2026: projects completed



## **Matching and Payments**

#### There are NO Matching Requirements

✤ No additional points will be given

#### Applicants May Apply for Advanced Payments

 Advance payments shall not exceed the amount necessary for project expenses for a three-month period and cannot reduce the project balance below 10% of the award amount.

#### Indirect Costs Allowance

 Up to 30% of total award may be used for Indirect Costs, including grant administration, accounting, printing, or utilities associated with the program.



## **After Awardees Are Notified**

- \* Track 1 and Track 2 Awardees will be Notified of their Grant Awards at the Same Time
  - If your application succeeds in receiving funding, a public announcement will be made to share who the awardees are.
- If you applied to Track 2 but <u>DID NOT</u> receive funding, you can still apply for Subaward Funding to a Track 1 CBO serving your region.
- Applying for a subaward after being notified that your application was not awarded funding IS ALLOWABLE. There is no guarantee that you will be selected by the CBO for a subaward.
- Track 1 Regional Leads will need several months to develop their subawards program
  - If interested in applying for a subaward you must communicate with the Track 1 awardee in your region directly not with CDFA.
